CALL TO ORDER: The meeting was called to order at 10:01 a.m. by Chairman John Sullivan. Quorum was established.

ROLL CALL: Commissioners Bashaw, Jones, Sullivan and Sweeney were present.

Each Commissioner declared they had no conflict of interest on any matter as listed on the agenda for today's meeting.

SPEAKER SERIES – APA Refunding Update: Darren Hodges, PFM provided an overview of the Series 2014 Bonds which were issued on March 27, 2014. They are Taxable Bonds reaching Final Maturity on October 1, 2045. PFM analyzed five separate refinancing scenarios as a way to mitigate rate increases and provide near-term cost relief. - The upper and lower basins are low due to little snow Currently, Lake Powell is at 30% and Lake Mead is at 35% of capacity

• Lake Mead is currently just below 1,075. By this time next year, we anticipate the elevation to be at the 1,040 mark.

o **Discussion:** The goal of the Executive Director Search Advisory Committee will be to review all applications received, conduct preliminary interviews and send

recommendations of the most qualified candidates to the Commission for final interviews.

- Consideration and possible engagement of Interim Executive Director
 - Following the discussion that took place in Executive Session, no action needs to be taken at this time. Any direction needed by the staff will come from the Commission through the Chairman.
- Possible Formation of Outside Legal Counsel Selection Committee Chairman Sullivan
 explained that there is a process in place through the Attorney General's office that is ongoing.
 This issue will be revisited when that process is complete and new APA Leadership is in place.
- Western Renewable Energy Generation Information System "WREGIS"/Western Area Power Administration "WAPA" Renewable Energy Credit Program Part of the Hoover Power Sales Contract (PSC) allows for the pass-through of environmental benefits and in this case renewable energy credits (REC's). The contracts would be through WREGIS/WAPA, Customers would obtain the certificate and then transfer the certificate to the APA. CRC Nevada recently went through a similar process which cost them \$7,000 \$11,000 for the year. It is a relatively inexpensive certificate and the APA has several customers who have indicated their interest in pursuing this matter. The cost of the certificate is an annual cost that would be supported by those customers who benefit from the certificate. There is no formal action to be taken at this time as the formal contract is not yet drafted.

Vice Chairman Bashaw had several questions regarding receipt of REC's and whether or not those REC's could then be transferred to APA Customers who might not have requested them earlier in the process. Mr. Gerak explained that the Power Sales Contracts address the fact that the REC's are not sellable or transferable. More analysis will be needed as this issue moves forward.

COMMISSIONER COMMENTS: Chairman Sullivan thanked Linda & Ed for their time at the APA and wished them well on their future endeavors.

VISITORS' COMMENTS/CALL TO THE PUBLIC: Dennis Delaney, & Doug Milligan thanked both Linda & Ed for their years of service to the APA.
